### BOARDING CONTRACT

Four Paws Pet Ranch, hereinafter known as "FPPR" and the undersigned owner or person having custody of the following animal agrees as follows:

- The undersigned requests FPPR board/provide daycare for the pet(s) named \_\_\_\_\_ & \_\_\_\_\_ and agrees to pay for each day of boarding/daycare and for all agreed upon services.
- FPPR agrees to maintain clean and sanitary quarters, to provide food according to accepted standards, but does not guarantee immunity against communicable diseases beyond its control. Should such sickness develop, FPPR reserves the right to incur the cost of the veterinary service, the cost of which the undersigned agrees to reimburse FPPR, but FPPR is not to be held liable if it fails to secure veterinary care.
- Upon failure of the undersigned to pay the board/daycare bill or fail to pick up pets as specified in this boarding contract, FPPR is hereby authorized to sell or otherwise dispose of said animal(s) in its absolute discretion per Civil Code #1834.5 (the abandoned animal act) which is clearly posted in the FPPR reception area and included in the welcome packet.
- All animals that are boarded or daycares, or otherwise cared for by workers of FPPR are without liability on their part for loss or damage from disease, death, running away, theft, fire or injury to persons or pets, or property by said pets or other unavoidable causes, due diligence and care have been exercised.
- The undersigned releases Four Paws Pet Ranch, its owners, and employees, from all risk and damages, which may occur during my pets stay.
- The provisions in this agreement apply to any future time the undersigned owner boards or daycares the same or other pets at the kennel. This agreement will be signed only once.
- Animals showing infestation of fleas and ticks will be shampooed and treated at the owner's expense of a maximum fee of \$35.00. We make every effort to maintain a flea free environment, however we cannot be responsible for occasional occurrences of fleas.
- Dog's paws may become irritated by the pebbles when they play in the play yards. All efforts are made to prevent dog's feet from becoming irritated, however, Four Paws Pet Ranch and its staff will in no way be held liable for any injuries to the dog's paws or to any other body part.
- Emergency Veterinary Care: In the event of a Pet(s) emergency, Client authorizes FPPR to seek emergency veterinary care for Clients Pet(s). Should Client's veterinarian be unavailable, FPPR is authorized to approve medical and/ or emergency treatment by a different veterinarian or animal care specialist. Client agrees to pay FPPR for any expenses incurred and to release and hold harmless FPPR from any and all liability for the Pet(s). If an emergency should arise and we can not reach the client or the emergency contract, client authorizes treatment of pet to a maximum dollar amount of: Pet 1 \_\_\_\_\_, Pet 2 \_\_\_\_\_.**
- Canine Cough can be contracted any time your dog comes into contact with another dog. All dogs boarding at the kennel have a current Bordetella shot, but the Bordetella vaccine is like the human flu shot and does not immunize all dogs against all strains of Canine Cough. FPPR and its staff will in no way be held liable for any strain of Canine Cough my dog may contract while at FPPR.
